PRESIDENT'S LETTER

Members and Friends,

First, I want to thank each of our 237 members who supported the Tacoma Lakes Association in 2020. Despite all of the difficulties associated with the COVID pandemic, you supported our efforts to maintain the high level of water quality in the Tacoma's. Donations, above and beyond the standard membership fee, grew in 2020. The TLA Board of Directors and Officers are extremely grateful for your support.

This summer the Plant Patrol team will again be on the lakes looking for any suspicious plants. They will be using an experimental, modified canoe, to assist in their efforts. See separate article in this newsletter. Fortunately, the Plant Patrol found no invasive species last summer.

The critical boat inspection program is already underway, and is our most important tool in protecting the lakes.

Our goal in 2021 is to increase the membership level to at least 300. This may seem like a substantial jump, but

considering there are between 400 and 500 lakefront property owners, we think this is an attainable goal. The cost of membership remains \$15 per year, making it easily affordable. A friend of mine recently purchased lakefront property in New Hampshire, and stated frankly, "the people on the Tacoma's take the excellent water quality for granted." Imagine all of the negatives associated with an invasive plant species taking root in our lakes, plummeting property values, and greatly reduced recreational activities.

I ask all of you who support our efforts to be vocal, encourage your neighbors old and new to join and help grow our Association and its valuable work.

TREASURER'S REPORT

TLA continued its string of successful financial years in 2020. Donations totaled \$8,640, eclipsing last year's total of \$7,395 by \$1,245. We received membership dues in the amount of \$3,555. This is a decrease from last year's dues in the amount of \$30 which equates to a net loss of 2 memberships. Membership for the year stood at 237 members. Net income for the year 2020 totaled \$9,189. An increase of \$443 over 2019. Total income from all sources increased by \$1,429 while total expenses increased by \$986. We were unable to hold our silent auction at the annual meeting in 2020, as the board decided not to solicit local businesses for donations because of the econimc impact of Covid-19. In 2019, the silent auction raised just short of \$1,000.

TLA remains in strong financial condition thanks to its generous members and donations from the community.

We have again received support from the State of Maine, the Town of Litchfield, and the Town of Monmouth. We thank them for their help and support.

Currently all bills are paid with no invoices outstanding. I am happy to answer any questions that the membership may have regarding TLA finances. LITCHFIELD BROADBAND COMMITTEE UPDATE

The goal of the Town of Litchfield Broadband Committee is to support the Select Board in bringing quality, affordable broadband service to all households and businesses in town. Over the past year, the Committee has completed the following:

- 1) ConnectMaine Planning Grant An \$8250 grant request was written by the Committee and awarded to the town. This grant covered 50% of the cost to develop a Planning Report for the mapping of current broadband capabilities in Litchfield. This completed Report includes mapping of served/unserved areas by incumbent service providers Charter Spectrum (cable) and CCI (Consolidated Communications phone DSL).
- 2) Maine Community Foundation Grant Another grant request was written by the Committee, and \$7000 was awarded to the town in October 2020. This provided funding for (a) a community hotspot at town hall, (b) upgraded video conferencing equipment for meetings there, and (c) computer literacy equipment and training for the Senior Center Advisory Group.

3) New Wireless Internet Provider to Litchfield -

TK Networks, a wireless internet service provider from Auburn met with the Committee in early 2020. With no infrastructure investment costs required by the town, TK Networks has connected over 100 previously unserved or underserved community households with affordable, quality broadband service. This activity was quite timely given the need of many to learn/work from home during the COVID outbreak. If you can see the Channel 10 tower from your place, you can get wireless broadband from this provider.

4) Digital Literacy Initiative at the Senior Center -

Laptops, tablet computers, and printers were procured for the Senior Center via the grant awarded by Maine Community Foundation. Some members of the senior advisory group participated in multiple 'Train the Trainer' workshops throughout the winter/spring.

5) Request for Quote (RFQ) - In March, the Broadband Committee sent out RFQs to a dozen internet service providers - including the incumbents Spectrum and CCI. Bidders have been provided a copy of the Planning Report. The purpose of the RFQ is to determine the best partner to support a build-out of the unserved and underserved areas. We need to consider better options that will address our broadband needs for the next 20 years. Many Maine towns are working diligently to accomplish this via fiber to the home (FTTH). Excellent broadband has become and will continue to be a huge factor in property values and economic stability of the

The Committee goal is to provide the town with broadband buildout options by mid-2021 to begin the selected plan implementation in the second half of the year with town approval



to move forward. Fortunately, significant grant money has recently been made available at both the state and federal level to support broadband infrastructure improvements in rural areas such as Litchfield.

Who knows if it will work, but it is an inexpensive way to figure out if it is worth spending money on the real thing.

DAM UPDATE

As the ice receded from the Tacoma Lakes this April, longtime dam tender Terry Averill noticed in his daily rounds at the Woodbury Pond Dam that there was evidence of a leak. He acted swiftly to alert the dam committee, which has led to a state inspection in April and an engineering assessment in May. Since the Lead Engineer Stephanie Hubbard has family on the Lakes, she comes not only with a top-flight structural and geotechnical team, but the perspective of a Tacoma Lakes, as well.

We now know that there is indeed a leak within the earthen berm, but Stephanie and the engineers from Wright-Pierce tell us that, if the water level at the dam is kept at 7 feet, only six inches under the normal summer level at the dam, then the dam leak can be effectively contained.

The other good news is that the Select Committee and Town Manager of Litchfield have moved quickly to seek options to fund a short-term repair. Meanwhile, the Town of Litchfield and the dam committee are exploring a more comprehensive plan, just as the Select Committee of Monmouth has also taken an active interest in the dam's repair.

The bottom line for those who love the Tacoma Lakes is that the dam is safe, short-term repair solutions are in process, and a plan to assure a generation's worth of restoration will be developed as needed.

And where is Terry Averill, the person we can thank for discovering the problem in the first place? Well, he continues to watch the dam, monitoring its safety as he makes his daily rounds at the Woodbury Pond Dam.



Maine Audubon keeps track of the loon population through an annual Loon Count. From 7 to 7:30 am of the third Saturday of July each year, over 1,000 volunteers venture onto lakes and ponds across the state to count loons. We are proud to have members of the Tacoma Lakes Association participating in this fun and important event. The observations recorded by our community scientist volunteers provide a "snapshot" of Maine's loon population on lakes throughout the state at the same time each year. From this data, Audubon staff are able to estimate the population and assess trends over time. For more than 37 years, citizen scientists have helped collect invaluable data to chart the status of our loon population.

The 2020 Loon Count took place on Saturday, July 18, 2020. Following the 2020 count, Maine Audubon estimated a population of 2,974 adult Common Loons and 414 chicks for the southern half of Maine. (Each year, our estimate is for Maine south of the 45th parallel roughly south of a line from Rangeley to Calais — which is the area where we have enough lakes covered by counters to make a reliable estimate.



Diane Clay coordinates the loon count for our area, Tacoma Lakes and others nearby. She recently spoke with Tracy Hart from Maine Audubon who is in charge of the statewide count. Tracy is hoping to get more eyes on loon nests in the future and collect more information than simply the annual data. Diane assured her that we have an enthusiastic group who have stepped up for counting loons, building nesting islands, and scouting nesting sites. We look forward to working with Tracy and the rest of the Audubon staff in the coming years. On a different note, Maine Audubon also provides training and information about keeping our yards full of native plants. They have done classes this year on "Bringing Nature Home in Maine" showing how to access native seed and how to raise the plants. They also hold a native plant sale in June. Native plants are




