### **ANNUAL MEETING**

The Tacoma Lakes Improvement Society held our annual meeting and breakfast on Saturday, July 14<sup>th</sup> 2012 at the Sportsman's Club in Litchfield. The breakfast started at 8:30 AM and ended at 9:30 AM. We had a record turnout of nearly 80 people. The breakfast was followed by a brief business meeting then excellent speaker presentations. ### **2012 MEMBERSHIP DUES NOW OVERDUE**

Your 2012 membership dues are \$15.00. A membership application is included in the newsletter. The assessment of the Tacoma Lakes was presented at the annual meeting. The result of the assessment is posted on our website. Town officials in Litchfield and Monmouth also received copies. It will now be up to each community to determine what, if any, action they wish to take regarding the report.

### **TREASURER'S REPORT**

Your Society is enjoying a very successful financial year in 2012. Membership is now the highest it has been in many years. We were successful in obtaining grants from the State of Maine, as well as the Towns of Litchfield and Monmouth. We're grateful for the incredible support from member donations, which are nearly double those in 2011. We thank our business advertisers, donors and friends leaving returnable bottles and cans at the Litchfield Transfer Station. We continue to carefully manage expenses, the largest of which is the inspectors at the boat launch. We will dedicate any surplus for future invasive species mitigation.

## PRESIDENT'S LETTER

Dear Members:

Due to unprecedented support from you and other members, 2012 was a record setting year for TLIS. With your help we were able to increase our membership level to a new high of 216 as of September 20. Financial donations were beyond our wildest expectations. Our July annual meeting and breakfast was a resounding success with a packed house, a display of the DASH boat, speakers from the Friends of Cobbossee Watershed and the Maine Forest Service, and our first ever silent auction. Needless to say, the pies and other desserts were such a success we plan on having even more next year!

The year 2012 saw new leadership at the Friends of Cobbossee Watershed. Its new Executive Director John Blouin has shown the energy and enthusiasm to continue to grow its membership base, invasive plant eradication activities and educational programs. He and his staff's efforts to eradicate the milfoil in Purgatory stream have amazed me and we cannot thank them enough for their efforts. I would encourage all members to lend their support to the FOCW and visit their website to stay current with their many activities.

As you all are aware, 2012 also saw the State allow the purchase and use of fireworks by citizens. Unfortunately, as with many well intended laws, misuse of these fireworks have resulted in many complaints to local municipal officials resulting in many towns and cities passing very restrictive ordinances or totally banning fireworks. A survey TLIS did at our annual meeting showed the majority of members agreeing with the opinion that fireworks over our lakes are damaging both to the water quality and wildlife. In addition, members complained that fireworks are frequently used after the 10:00 pm deadline. TLIS officers fully intend to participate in a committee being set up by the Town of Litchfield to explore whether regulation is required and we are committed to presenting your views to the local officials, both in Monmouth and Litchfield.

Terry Averill, Dam Keeper, has continued to do an outstanding job on maintaining the water level in our lakes and both the town and TLIS would be hard pressed to ever replace him. The dam continues to be in good condition, although some remedial work is still pending in regards to the placement of additional rip rap and other minor work. Hopefully this work can be accomplished in 2013 since it has the full support of municipal officials.

As usual, the workload for your directors of TLIS never seems to decrease and we appreciate your patience with us as we continue to strive to improve our services to you and maintain our lake system as one of the best in central Maine!

## Milfoil Control Continues in 2012 on Purgatory Stream

The surprising discovery of variable-leaf milfoil in Purgatory Stream in 2010 has resulted in the combined efforts of the Friends of the Cobbossee Watershed (Friends) and Tacoma Lakes Improvement Society (TLIS) in removing the plants from the stream. First noticed by Cobbossee Watershed District scientist Ryan Burton, the milfoil infestation is located in the part of the stream sometimes referred to as “Mill Pond” by local residents, which is the area just upstream of the dam at the intersection of Whippoorwill and the Hallowell/Litchfield roads. Thankfully downstream of the Tacoma Lakes, the infestation is still uncomfortably close to those non-infested water bodies, and the reason for the concentrated efforts of the two organizations to work towards eradication of the plant in Purgatory Stream. Variable-leaf milfoil, also present in Horseshoe & Pleasant Ponds and Cobbossee Stream, can quickly plague native ecosystems, disrupt recreational activities like swimming and boating, and drastically reduce property values.

Since the stream is shallow and not very wide, only small boats or non-motorized kayaks and canoes can access the water. Removal efforts therefore have been focused on the physical hand removal of plants, as well as the use of “milfoil mats” placed on the bottom of the stream over patches of growing plants. The mats, also referred to as benthic barriers, are made up of weighted tarp-like fabric that prevents sunlight from reaching the plants, inhibiting growth. The mats are left in place for one to two months, and then removed, with the hopes that native plants will reestablish the area first.

In a serious effort to have an impact on the Purgatory Stream infestation the Friends increased the number of 10’ X 12’ milfoil mats placed from (35) in 2011 to 80 this summer. Fifty mats were originally placed in late May; in late July 30 of the mats were picked-up and moved to another location in the stream, to cover more area. By mid-September, when the final mats were removed from the water, 9,600 square feet of milfoil-infested stream bottom had been covered this summer alone. Combined with hand pulling efforts by Friends staff and TLIS volunteers, the 2012 season has been extremely successful in fighting back the growth of milfoil in Purgatory Stream. The Friends plan on continuing this partnership with TLIS in the years to come, with hopes that in three to five years of sustained effort, we will be able to eradicate this invasive from Purgatory Stream!

## LAKE LOWERING

This year's lake drawn down will start on October 15, 2012 according to dam keeper Terry Averill. Please make sure you have removed any boats, docks, etc. prior to then if this lowering will cause you additional difficulties. As a cautionary note, the beaver dam on Jimmy stream is currently passable but may not be once the water level is lowered.

## THANK YOU FRIENDS OF COBBOSSEE WATERSHED

The Friends are an amazing partner to TLIS. Their work benefits our entire watershed, not just the Tacoma Lakes. The Friends provided the following services to TLIS in 2012:

Managed the paid inspectors, ensuring our boat launch was covered on holidays, Fridays, Saturdays and Sundays.

The Friends provided payroll service, insurance and payroll taxes for the paid inspectors working the Woodbury Pond boat ramp. TLIS only had to reimburse them for these costs.

Arranged for Friends staff and paid divers for the milfoil remediation on Cobbossee Stream. They also provided the benthic barriers. TLIS volunteers assisted. This was the second year of this project, which will continue next year.

Filed reports on our behalf for the state grant.

Friends Executive Director John Blouin made a presentation at our 2012 Annual Meeting.

Coordinated and provided paid staff for the milfoil mediation in Purgatory Stream.

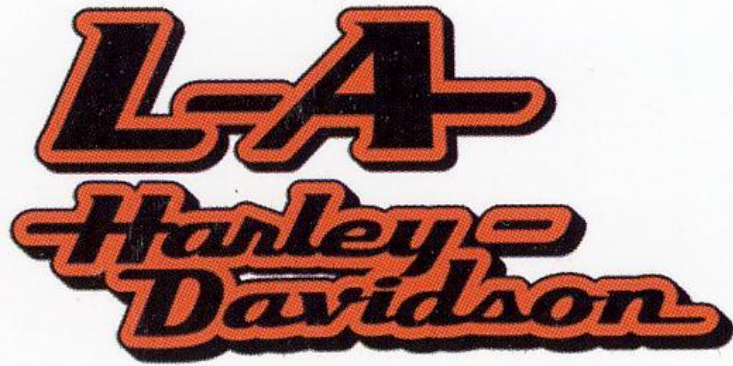
## **HISTORY OF TACOMA LAKES**

## **THANK YOU JOHN STORY AND NELLY GAMAGE**

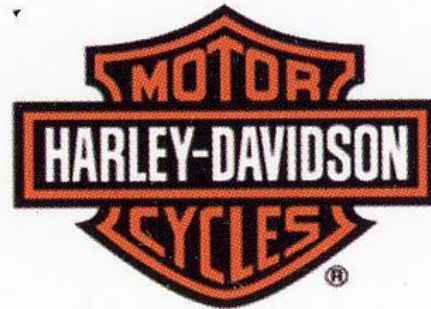
